Subject: Updated Cultural Resources Records Search for the Gateway Specific

Plan Project, Grand Terrace, San Bernardino County, California (BCR

Consulting Project KIM2228)

Dear Kari:

BCR Consulting LLC (BCR Consulting) was retained by Kimley-Horn to complete an updated cultural resources records search for the Gateway Specific Plan Project located in the City of Grand Terrace, San Bernardino County, California. Changes to the Specific Plan boundaries and recent comments to the 2019-records search received from Brian F. Smith have necessitated this updated report. This report may also be used to supplement results from Tang 2022. The project site is located in Sections 5 and 6 of Township 2 South, Range 4 West, San Bernardino Baseline and Meridian. It is depicted on the United States Geological Survey (USGS) San Bernardino South, California (1980) 7.5-minute topographic quadrangle (Figure 1).

Cultural Resources Records Search

BCR Consulting Principal Archaeologist David Brunzell, M.A., RPA conducted the updated cultural resources records search at the South Central Coastal Information Center (SCCIC) at California State University, Fullerton. A small portion of the records search radius is in Riverside County. Cultural resource records for Riverside County are housed at the Eastern Information Center (EIC) at the University of California, Riverside. Access by non-employees is still not allowed at the EIC due to Covid 19 restrictions. Updated data has been requested from EIC staff but has not been received yet. It is not likely that updated results for this area will change results significantly. The updated records search from the SCCIC included a review of all recorded historic-period and prehistoric archaeological sites, as well as built environment resources within one half-mile of the project site. The research also reviewed known cultural resource reports completed in the vicinity. The research revealed that 21 cultural resource studies have taken place resulting in 18 cultural resources recorded within one half-mile of the project site (excluding the area in Riverside County). None of the previous studies has assessed the project site, although SCCIC records indicated that two cultural resources have been identified within its boundaries. The resources identified within the project site boundaries include a segment of the historic-period Riverside Canal (designated P-36-7169) and a segment of Union Pacific Railroad (P-36-6101). The SCCIC records search results are summarized in Table A, and a bibliography is provided as Attachment C.


